Simply Sewing issue 148 – sewing bundle –Terms & Conditions

1. The Promoter is Our Media Limited (company number 05715415) a company incorporated in England and Wales whose registered address is at Eagle House, Colston Avenue, Bristol, BS1 4ST.
2. The promotion is open to all residents of the UK, including the Channel Islands, to people aged 18 years or older, except the Promoter's employees or contractors and anyone connected with the promotion or their direct family members.
3. The closing date for entries is **11.59pm on 8th July 2026**.
4. By entering the promotion, the participants agree:
 - a. to be bound by these terms and conditions; and
 - b. that should they win the promotion, their name and likeness may be used by the Promoter for pre-arranged promotional purposes.
5. Entrants should enter by entering their name and email via the Riddle hosted on simplysewingmag.com/win. Entries received after the closing date of the promotion will not be considered.
6. Entrants must supply to Our Media Limited their personal data required for us to run competition, choose winners and arrange for prize to be sent to winners – examples would be name and email address.
